### **Special terms and conditions of sale**

The Customer undertakes to strictly respect these terms and conditions in relation to the use of the 2013 Clio 98 Cup single-seater equipped (hereinafter referred to as “Cup 98 Cup ”) :

- a. The Customer expressly undertakes not to alter in any way whatsoever the identifying items on the Clio 98 Cup (e.g.: chassis number, etc). He shall be held entirely responsible for any alteration.
- b. The Customer shall be entirely and exclusively responsible for the use of the Clio 98 Cup . Hence, by signing this order form, he takes on all direct and indirect risks associated with usage thereof. Furthermore, he shall refrain from taking any form of proceedings, and irrevocably abandon any form of recourse, claim, complaint or legal action against RST, RENAULT s.a.s. and any other affiliated company to the RENAULT group, arising in any way whatsoever in the event of material damage and/or bodily injury suffered by the driver, the Clio 98 Cup 2013 and/or third parties or arising from the use of the Clio 98 Cup .

The Customer guarantees Alpine RENAULT, RST, RENAULT s.a.s. and any other affiliated company of the RENAULT group against any form of recourse that may be exercised by whomsoever among customer’s agents, beneficiaries or a third party, due to use of the Clio 98 Cup .

RST’s general terms and conditions of sale, which the Customer accepts, shall govern this operation. Moreover, by signing these terms and conditions, the Customer expressly abandons any application of his own terms and conditions of purchase.

**The order shall be confirmed upon receipt of the full amount of a down payment of 20 %.**

Failure to comply with an obligation on the part of the Customer will entitle Alpine RST to suspend execution of orders in progress ipso jure and without prior notice until the payment of sums owed and/or to cancel all orders, however default interest shall remain owed from the due date of payment and in application of the legal rate.

Delivery of the Clio 98 Cup shall be made as soon as it becomes available from RST - address: to ALPINE RENAULT and after receipt of the full balance of the total price.

The date limit for payment of the balance of the total price shall be one (1) week before the delivery, at a date which will be communicated to you in due course. No delivery will take place without full payment of the sum indicated above.



**CLIO CUP**

Execution of the order may be suspended by RST in the event of a case of force majeure. Force majeure means any unforeseen and irresistible event or circumstances beyond the reasonable control of the parties as defined by French courts. The deadline for the execution of the order shall be prolonged throughout the duration of the force majeure event and the resulting consequences. Should the case of force majeure delay the execution of the order by more than three (3) months, each of the Parties shall be entitled to cancel the order. No indemnity shall be due in the event of delay or cancellation due to a case of force majeure. All delivery dates mentioned are indicative. Consequently, in case of delay, the Customer shall not be entitled to claim damages and interest.

Collection of the car , which shall be conditioned for shipping beforehand (option), shall take place at the address indicated below (DELIVERY address)

Transfer of risks of loss and damage is effective at the time of pick-up of the car or of the kit by the carrier specified by the Customer at the above-indicated address. Shipping and insurance costs shall be borne by the Customer.

The Customer undertakes to subscribe civil liability insurance with a reputable insurance company for as long as his responsibility is liable to be engaged. This insurance shall cover third parties, for a sufficient amount, for prejudice liable to arise from his responsibilities in relation to the use the Clio 98 Cup .

Any dispute arising from the interpretation or execution of these terms and conditions and which has not been able to be settled amicably between the Parties, within a period of one (1) month from when it occurred, shall be placed before the competent courts of Paris. French law shall apply.

## GENERAL TERMS AND CONDITIONS RELATING TO THE MARKETING AND SALE OF COMPETITION PARTS

The present general terms and conditions of sale apply to mechanical parts, collections (kits) and COMPETITION items of clothing marketed by RENAULT SPORT TECHNOLOGIES (RST below). COMPETITION parts sold by RST are intended to be fitted, exclusively, to vehicles used in motorsport competition. They must be assembled in accordance with practices currently in force in this area of activity. The fitting of these parts onto a standard production vehicle therefore means the latter can only be used in competition and not on the public highway. It renders approval from the French government vehicle testing department null and void. Importers, Dealers and their Agents, and also Vehicle Assemblers do not act as Authorised Agents of RST, where special COMPETITION parts are concerned. They act therefore in their own name and remain solely liable with respect to their own customers in relation to any commitment entered into by them.

Any change to our general and particular terms and conditions must be agreed by mutual consent between the parties.

**ORDER :** Within the framework of current legislation, RST reserves the ability to modify the manner in which its COMPETITION spare parts are manufactured to take account of technical developments and the need to improve the quality of its products.

**DELIVERY :** RST COMPETITION parts as listed in COMPETITION catalogues are in principle held in stock in its warehouse. However, due to circumstances that may have an influence on production, certain parts may not be able to be delivered immediately. In this case, where the customer is a consumer, the order will be maintained in line with the initial terms and conditions save for a written request on his part. In order not to be ruled out of time, claims for parts that are missing or obviously defective will have to be submitted :

- at the time they are up-lifted, if the customer takes delivery from our stores;
- within three days of their receipt, if they are shipped by ourselves to the Customer's address.

**PRICES :** The maximum price applied by RST for its parts and components will be the one shown in its price lists. However, prices shown in these price lists may be modified without notice. All of our prices are in Euros and are "Ex ALPINE RENAULT stores".

**TRANSPORT :** Save stipulations to the contrary agreed in writing between the parties, all goods shipped within France or abroad, travel at the risk and peril of the recipient. It is the responsibility of the latter to bring reservations to the attention of the carrier, in accordance with legislative parameters, in relation to missing or damaged goods noted on arrival.

**WARRANTY :** RST COMPETITION parts are not covered by any particular warranty.
